An NFT, Non-Fungible Token is a "cryptographic token" that represents a specific item, be it digital or physical, on a blockchain.

NFTs use blockchain technology (evidence-based operations) similar to that of cryptocurrencies and are mostly associated with the token ETH Ethereum.




